#### 1. STRATEGIC FOUNDATION AND IDENTITY

The International Association for Child and Adolescent Psychiatry and Allied Professions (IACAPAP) is a non-governmental organization (NGO) that advocates for the promotion of mental health and development of children and adolescents through policy, practice and research.

A world in which all children grow up healthy, emotionally as well as physically, and realize their potential to contribute to their society

- Advocate for the promotion of the mental health and development of children and adolescents through policy, practice and research in different countries, with a special emphasis in those countries where child and adolescent mental health is less developed/acknowledged
- Promotes the study, treatment, care and prevention of mental and emotional disorders and disabilities involving children, adolescents and their families with emphasis on collaboration among the professions of child and adolescent psychiatry, psychology, social work, paediatrics, public health, nursing, education, social sciences and other relevant disciplines.

To achieve its mission, IACAPAP has developed and adopted the guidelines and principles of Ethics in Child and Adolescent Mental Health. IACAPAP also adopts Declarations & Statements, Position Papers and Monographs to help child and adolescent mental health professionals in their work.

#### 1.3 Values

To conduct its work in accordance with high ethical standards, IACAPAP has adopted and developed the guidelines and principles of Ethics in Child and Adolescent Mental Health (CAMH) (IACAPAP Ethics 2006). The values enshrined include (but not restricted to) Competency, Respect, Protection, Beneficence and Non-Maleficence, Justice in clinical, education and research for children and adolescents.
